Please know that a client who chooses me as their therapist understands that I do not take insurance in this solo practice. Also, I provide an affordable service for client's who cannot afford today's high counseling costs. The rate that a client begins seeing me is set at \$50-\$60 for Individual or Couples therapy. However, during therapy, this rate may be waived if the client comes into hard times financially. Clients who find themselves well off financially may offer to give more money for services rendered if they so desire and are feeling my counseling services are benefiting them. Clients are not expected to sign any contract or pledge that they will give more. A client's giving more when they can, helps me to afford to see other clients who cannot afford therapy or enter hard times financially. If a client enters therapy and is hindered by low income, such as being on disability, the \$SO-60 fee can be waived from the onset. The said fee is for modes of counseling including individual, family, and couples except for group counseling with the fee being \$20-\$30 per session. Disclaimer

This Good Faith Estimate shows the costs of items and services that are reasonably expected for your health care needs for an item or service. The estimate is based on information known at the time the estimate was created.

The Good Faith Estimate does not include any unknown or unexpected costs that may arise during treatment. You could be charged more if complications or special circumstances occur. If this happens, federal law allows you to dispute (appeal) the bill.

If you are billed for more than this Good Faith Estimate, you have the right to dispute the bill.

You may contact the health care provider or facility listed to let them know the billed charges are higher than the Good Faith Estimate. You can ask them to update the bill to match the Good Faith Estimate, ask to negotiate the bill, or ask if there is financial assistance available.

You may also start a dispute resolution process with the U.S. Department of Health and Human Services (HHS). If you choose to use the dispute resolution process, you must start the dispute process within 120 calendar days (about 4 months) of the date on the original bill.

There is a \$25 fee to use the dispute process. If the agency reviewing your dispute agrees with you, you will have to pay the price on this Good Faith Estimate. If the agency disagrees with you and agrees with the health care provider or facility, you will have to pay the higher amount.
